





By obtaining these certificates, companies can showcase their commitment to ethical and sustainable practices, providing transparency and assurance to consumers.


How can I determine if I am eligible for certification?


Check if you meet the certification criteria by consulting the EVE Vegan® Compliance Standards and Certification Procedure.

Submission of comprehensive and up-todate technical documentation regarding product formulas, raw materials, labelling, and packaging is mandatory for products seeking certification. Furthermore, the certification process includes an on-site audit (tailored to the project's specifications) to assess the adequacy and effectiveness of the company's quality system in ensuring ongoing product conformity.


Outsourcing: If subcontracting is involved, prior agreement from the subcontractor is required to undergo a certification audit, if applicable.






